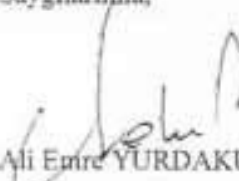
İlgi: İslam Ticaret ve Sanayi Odasının 27/04/2010 tarihli ve 17/ITCS/0463 sayılı yazısı.
